- **Introduction and Acronym Soup** – Terms and definitions for better understanding.
- **Certification** – Identification and recommended practices for managing vessel certificates.
- **Company Safety Policy** – A critical foundation and bridge to keeping it simple.
- **Competence and Training** – Untangling the knot to ensure competent and qualified personnel.
- **Hazard Identification, Risk Assessment and Control** – Explore a way that shoreside and vessel personnel can agree on and keep the focus on what is most important.
- **Legal and Other Requirements** – Identifying what is your greatest liability and turning that into your greatest asset.
- **Health and Safety Objectives and Targets** – Taking a complicated concept and simplifying for Company-wide involvement and buy-in.
- **Designated Person Ashore** – How is this role best served and by whom.

- **Emergency Preparedness and Response** – Identifying what is most important to ensure the intent is accomplished without unnecessary tools and fluff.
- **Inspections and Audits** – Learning the differences between the two and how best to benefit from both.
- **Nonconformance and Observations** – Friend or Foe? Discover how to change the negative to a positive?
- **Incident Investigation** – Mining for gold.
- **Corrective and Preventive Action** – Exploring long term solutions.
- **Management Review** – what to cover, how best to capture input and how to role out action plans for sustainable continual improvement.
